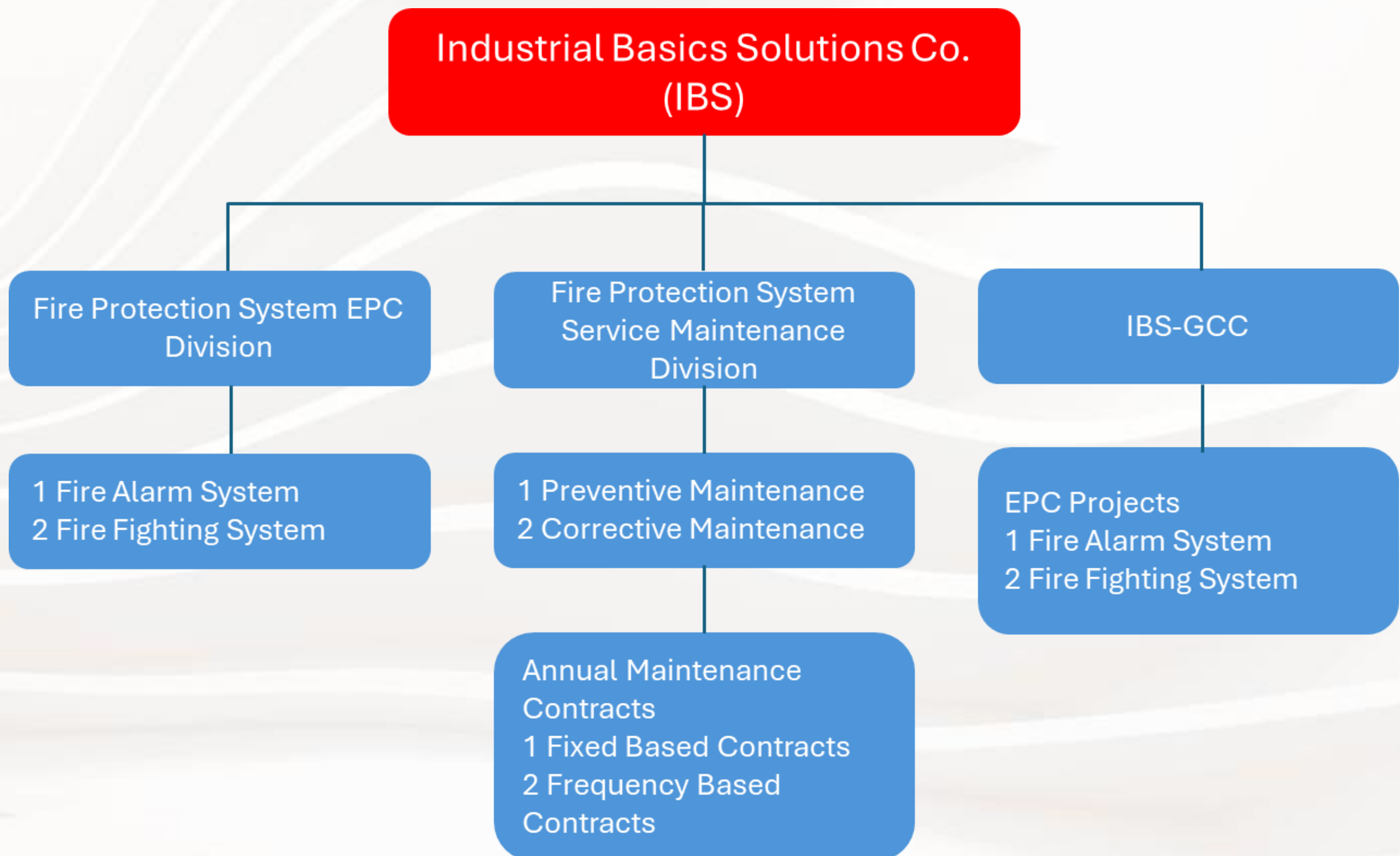

## Testing of Installed Systems:

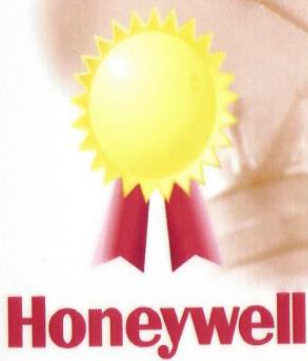
